EBSCO Legal Source is an academic database of full-text articles on current issues, studies and trends in law and criminal justice. The content of the database is useful for lawyers, paralegals, educators, university students and others involved in these fields of knowledge.

The journal is also pleased to publish the article “Human rights - Youth - Public policies. A Latin American and Uruguayan dilemma remains unresolved”, by Alejandro Klein Caballero, Research Professor at the University of Guanajuato, Mexico and Associate Fellow - Oxford Institute of Population Ageing.

The article “Human rights - Youth - Public policies. Latin American and Uruguayan dilemma remains unresolved ”seeks to generate some reflections on the field of public policies aimed at youth in Latin America and, especially, in Uruguay. Its method focuses on an investigation of the sources related to the subject with a critical comparative analysis of the data, to which were added reflections on the fluctuations between the state of well-being and neoliberalism and some psychosocial characteristics that arise from them. Among the results obtained, the need to thoroughly review the concept of “youth” and “adolescence”, crossed by a social imaginary, idealizer or denigrator, which does not allow to adequately define the social “subject” to which these public policies are targeted.

It is indicated, as a relevant factor of the final considerations, that, in this sense, it is necessary to include demographic variables, gender, historical processes, new types of emerging culture (such as urban tribes), rural-urban differences and family transitions, among others, to precisely redefine this social "subject" and obtain an effective resizing of public policies.

Case study ”, by María Luisa Soriano González, PhD professor hired at the Pablo de Olavide University in Sevilla in the Department of Public Law, in the area of Philosophy of Law. Degree in Philosophy from the University of Sevilla and European doctor in political thought, España; “Genealogía de la desigualdad, by Carlos Manuel Rosales García, Doctor of Law from the University of Chile; “Reflections on the fulfillment and execution of the fallings of the Inter-American Court of Human Rights (CORTIDH)”, by Raul Montoya Zamora, Doctor of Law from the Juárez University of the State of Durango, Mexico, Research Professor at the Juárez University of the State of Durango, Mexico; “Latin American constitutionalism.
