In this article "The food sustainability challenge beyond consumption: an attempt to construct a new model of "conscious Individuals" is addressed to the epistemological question about the notion of "consumer" on the food regulations of the European Union, offering some proposals for a change of definition and perspective. The analysis starts from Regulation No. 1169/2011 of the European Parliament and the EU Council on the provision of information to consumers foodstuff, and vis-à-vis dilemma of notification requirements and information to consumers. Next, the article examines the legal provisions to understand if there are already initiatives to a participatory approach, which may involve consumers as active participants in the food supply chain. The final part of the article is devoted to possible ways to find a new definition of food safety in the various consumer chains.
