The Journal of City Law, a journal rated by MEC / CAPES as Qualis A1, Law and registered in the Web of Science, is pleased to inform all its readers that it is now also indexed in PLUMX METRICS by PLUM ANALYTICS.

PlumX metrics provides insights into how people interact with individual search results (articles, conferences, book chapters, etc.) in the online environment. Examples include when the search is mentioned in the news or it comes to tweet about the search. Collectively known as PlumX metrics, these metrics are divided into five categories to help understand the huge amounts of data involved in social media and enable analysis by comparing similar characteristics of search metrics appropriate for all types of search results academics.

We published in this issue the article "Towards a democratic conception of democratic judgment lato sensu and the democratic judgment in Mexico from the theory of the prohibited limits" of Professor Joaquin Ordoñez, Professor of the Faculty of Law of the Autonomous University of the State of Mexico, Mexico.

This article "Towards a democratic conception of democratic judgment and democratic judgment in Mexico from the theory of the prohibited limits" describes some theoretical conditions necessary to conceptualize the democratic judgment lato sensu of certain concepts of the theory of the prohibited reserve, with the objective to investigate the characteristics and requirements to qualify a judicial process as democratic. It is based on the idea that democratic judgments should be carried out not only in the electoral courts, but must operate in all jurisdictional activities, hence their broad meaning (lato sensu). It is proposed that in all jurisdictional activities, democratic aspects be influenced if the social objective of effective and efficient justice administration is achieved, for which some categories of the prohibited reserve theory are considered. Finally, for the democratic judgment, lato sensu can be applied in reality, it is necessary that the judge be democratic, whose qualities and characteristics are also delineated of said theory.

In our Section Essays we published five (5) unpublished essays, two of them on urban land conflicts: *"Urban land conflicts in law power: discursive strategies mobilized in the basis of the decisions"* By Giovanna Bonilha Milano, PhD and Master in Law of Relationships, the Federal University of Paraná - UFPR. Professor of undergraduate and postgraduate courses at Positivo University. Researcher of the Research Group "Human Rights, Democracy and Social Conflicts" (UFPR); and *"Right to housing and judicial conciliation of collective land tenure conflicts: the experience of Porto Alegre"* by Prof. Cláudio Ari Mello, Professor of the School of Law at the Pontifical Catholic University of Rio Grande do Sul, Porto Alegre. Doctor in Theory of Law by UFRGS, Master in Law of the State by PUCRS.

In this issue of the Journal we have also broadened our body of our reviewers / evaluators, with the inclusion of many Professors from countless States of the country and also from many foreign professors.
