We publish in this issue the article *"Being a neighbor: political and moral hierarchies in the history of Buenos Aires"* Professor Matías Landau, Professor at the University of Buenos Aires - UBA, Argentina, PhD in Sociology from the School of Higher Studies in Social Sciences (EHESS), Paris; Doctor in Social Sciences, Master in Research in Social Sciences and BA in Sociology from the University of Buenos Aires (UBA). Research assistant at CONICET, based at the Gino Germani Research Institute (IIGG).

This article "Being a neighbor: political and moral hierarchies in the history of Buenos Aires" analyzes the category of neighbor and its long history. The term has designated, in different moments, specific forms of conceiving the collective bond that unites the inhabitants of the city, delimiting forms of inequalities and hierarchies, as much in legal-political terms as governmental and moral. The article proposes a socio-historical analysis of its main transformations, from the nineteenth century to the present. It uses a documentary method, from a multitude of diverse sources that include laws, regulations, parliamentary debates, specialized magazines and newspapers. The historical analysis shows that, parallel to the universalization of the category of the neighbor, after the universalization of the municipal vote, it was erected as a tool of governmental management, allowing the differentiation of different groups of the city, while being consolidated as an effective form of moral evaluation of the city dwellers.
