This article "Note sulla riforma del libro III del Codice Civile francese: multo rumore per nulla" This article deals with the reform of book III of the French Civil Code. This reform, although widely and for a long time discussed, is not and did not want to be revolutionary. It must be seen in the context of the European debate on the unification of contract law, which also provides a key to the interpretation of the reform. The values of the bourgeoisie replaced the protection of the weaker subject, the citizen becomes a consumer, the autonomy of the individuals is blurred by solidarity, the code as an expression of a state order must face the challenges of globalization, the political profile of the bourgeoisie and multinationals, which change the role of the state itself. Europe, through its regulations and directives, imposes its private law, often with indifferent indifference to the traditions of the countries to which its directives are strongly bureaucratized, while at the same time discussing its "democratic deficit." Perhaps reform could do no more than simplify and modernize. As argued in the article, it is not easy to predict whether the new rules will have the strength to resist changes already outlined or whether they will be temporary rules of limited duration, as is the fashion of these times, waiting for a horizon that is not seen, or better, that today we are not able to see what it will be.
