We published in this issue the article "Exploring Housing Conditions Through Children's Eyes" by Prof. Jaime Hernández-García, PhD from the University of Newcastle Upon Tyne in the United Kingdom and professor at the School of Architecture and Design at the Pontifical Javeriana University of Bogotá, Colombia and Milena Rincón Castellanos, assistant professor at the School of Architecture and Design at the Pontifical University Javeriana from Bogotá, Colombia.

This article "Exploring Housing Conditions Through Children's Eyes" presents a methodology to explore housing conditions through the perception of children living in informal settlements, using photography as a research tool. Informal housing is generally in poor condition, affecting users' health and often putting their lives at risk; but this is not always something that users know about. In this sense, finding ways to make poor housing conditions visible can contribute to their improvement. With this in mind, the article addresses children's perceptions of their homes and how these observations and perceptions can contribute to improving the quality of life in these poor areas. The research was carried out with children from 6 to 12 years old, living in informal settlements in the southern periphery of Bogotá, Colombia. The findings confirm "old topics" about housing conditions and open up "new topics" as well; all of them defined by the children's perceptions. In this sense, the findings can help built environmental practitioners and informal builders understand how housing conditions affect children's health and well-being and support the exploration of alternative housing solutions.
