EDITORIAL FOR VOL. 12-3 (2020)

The Journal of City Law, a journal classified by MEC / CAPES as Qualis A1, Law and registered on the Web of Science, is pleased to inform that our Journal was cited in a decision by the Supreme Federal Court, by Minister Roberto Barroso, on a Direct Action of Unconstitutionality - ADO nº. 60, proposed by the Partido Socialista Brasileiro - PSB, by the Partido Socialismo e Liberdade - PSOL, by the Partido dos Trabalhadores - PT and by the Rede Sustentabilidade, which narrate commissive and omissive acts of the Union that would compromise the proper functioning of the National Fund on Climate Change (Climate Fund), as well as the right of all Brazilians to a healthy environment (CF, art. 225, caput and paragraphs).

In that decision, Minister Roberto Barroso admitted that the action is an allegation of non-compliance with a fundamental precept and, without prejudice to the information to be provided by the defendants, convened a public hearing for the 21st and 22nd of September 2020, considering that the case involves the need for a broad understanding of the current state of public policies in environmental matters, of the operationalization and functioning of the Climate Fund and of the various actors and activities eventually impacted by such policies and that these issues go beyond the limits of the strictly legal, demanding interdisciplinary knowledge about scientific, socio-environmental and economic aspects.

We published in this issue the article “Transformations in labor matters and impacts in Argentine cities during the last decade (2010-2019)” by Prof. Rodrigo Carmona, from the Instituto del Conurbano, National University of General Sarmiento, Argentina.

This article “Transformations in labor matters and impacts in Argentine cities during the last decade (2010-2019)” seeks to examine the main transformations in labor issues that have been taking place in contemporary capitalism and their concrete impacts on cities. Greater vulnerability, informality and precarious work are present in different contexts, with particular implications at the territorial level and varying according to the policies applied to moderate or intensify their effects.

In this context, the article analyzes the evolution of the main labor indicators in Argentine cities during the last decade (2009-2010 period). The article verifies how the urban labor market works based on official and aggregated information from 31 clusters (with more and less than 500 thousand inhabitants). A specific analysis of the last four years is also made in

relation to urban agglomerations with major work problems, based on different indicators (activity rate, employment, unemployment, people looking for a job and underemployed) and their derivations in terms of policies implemented. In these terms, the worsening of the Argentine labor situation, although appearing as a consolidated trend over the last decade, is more serious between 2016 and 2019 due to the neoliberal measures implemented in the cities, especially the large and intermediate ones.

As in the issues previously published, in the present volume 12, number 03, we published 16 (sixteen) unpublished articles, with 4 articles from foreign professors: the aforementioned "Transformations in labor matters and impacts in Argentine cities during the last decade (2010-2019)" By Prof. Rodrigo Carmona, from the Instituto del Conurbano, National University of General Sarmiento, Argentina; "The effect of compliance with environmental standards on informational content of foundational figures of accounting" by Giti Azam Shahverdi, Instructor at the Ershad Damavand Higher Education Institute and Nafiseh Ashena, Master of The Arts in Accounting at the Ershad Damavand Higher Education Institute, in the Islamic Republic of Iran; "The right to city, a legally demandable right in Argentina?" by Tamara Belén Rogers, PhD student in Law at the National University of Mar del Plata, Argentina; "We have worked this land with our hands to inhabit it': the conformation of collective subjects and the value of work in creating local senses of rights in Greater Buenos Aires, Argentina", by Lucila Moreno, PhD at the University of Buenos Aires with orientation in Social Anthropology.
