It is a comprehensive database covering all subjects from arts and humanities, behavioral sciences and social sciences to medicine and pharmacology, physical sciences, mathematics and computer science, chemistry and biology.

In this issue we publish the article "Localization and structure of opportunities: the peripheral environments of social housing developments in the city of Córdoba (Argentina)", by María Cecilia Marengo, Full Professor at FAUD - UNC, independent researcher of CONICET, Institute for Housing Research at FAUD - UNC, group linked to CEUR - CONICET, Professor of the postgraduate program in the Doctorate in Architecture and of the Master's careers in Housing Management and Development and Architectural and Urban Design at the School of Architecture, Urbanism and Design - National University of Cordoba - UNC, Argentina and Ana Laura Elorza, PhD, Master in Housing Management and Development (FAUD UNC), Degree in Social Work, adjunct researcher of CONICET - Housing and Housing Research Institute (FAUD-UNC) and Professor of the Degree in Social Work of the Faculty of Social Sciences of the National University of Cordoba, Argentina.

In this article the authors analyze the geographical localization of different social groups in the city of Cordoba and verify whether it is related to differentiated modalities of access to urban resources present in a given locality, which highlights processes of socio-territorial inequality. The objective of the article is to address the evolution of peripheral urban sectors formed from a public housing policy implemented in the city of Cordoba (Argentina), in relation to the structure of opportunities that unfold in the territory, as an expression of the differential consolidation processes of each neighborhood derived from a particular location in the urban space.

The methodology used is quantitative and comparative, based on the use of Geographic Information Systems (QGis Software) over which the systematization of the data collected in the field is performed. The results point to differences in terms of urban consolidation, linked to the initial conditions of urbanization and the evolution of environments. These conditions lead to question the role of public housing policy in the construction of the peripheral neighborhood space, the structure

of opportunities that unfolds in the process of growth by extension and its relationship with the right to the city.
