We also published in our Section Monographs an encouraging study entitled *Discussing The Concept Of Legitimacy In The Current Context*, by Marcelo Machado Costa Lima and Francisco Romão Ferreira, respectively, Doctor of Law by the University of Lisbon and professor of undergraduate and postgraduate courses at the University Estácio de Sá and the law course of Ibmeq; PhD in Sciences by the National School of Public Health and postdoctorate focused on the teaching of biosciences in health by Instituto Oswaldo Cruz / FIOCRUZ.
