We publish in this issue the article "The historical construction of the beneficiary: policies of Dominican regularization in Santa Fe (1985-2017)" by Professor Emilia Mosso, PhD in Architecture from the National University of Rosario, Argentina, postdoctoral fellowship by the National Council of Scientific and Technical Investigations (CONICET) and member of the Research Institute for Urban Development, Technology and Housing of the School of Architecture, Urbanism and Design of the National University of Mar Del Plata, Argentina.

This article "The historical construction of the beneficiary: policies of Dominican regularization in Santa Fe (1985-2017)" deals with the relationship established between the historical instrumentalization of urban policies and programs - linked to the regularization of the domain - in the configuration of the recent socio-spatial order; and how this instrumentalization contributes to the spatial location of the impoverished population in the city of Santa Fe, Argentina, over the last three decades. It proposes a combined qualitative and quantitative methodology, based on a strategy of analytical approach supported by several instruments (analysis of documents, regulations and publications, semi-structured and in-depth interviews, fieldwork, clothing mapping and mapping). In this context, based on the analysis of four urban programs linked to the dominance regularization, two of them instrumented three decades ago, and the others since the last decade, this incidence is analyzed in the socio-spatial conformation of Santa Fe and, specifically, in the locality of the population impoverished, designated by several agencies as beneficiary. It is concluded that while the programs analyzed incorporate several policy instruments to regulate property, they contradict it: it is the historical instrumentalization of a public policy that promotes, endorses and defends property, but reproduces precarious conditions of ownership.
