The article *The protection of migrant children, the best interest and their relationship with trafficking in people in Mexico* advocates that human rights must be guaranteed to all human beings; the principles that permeate them as universality, interdependence, indivisibility and progressivity are not sufficient in themselves, and must be respected by each and every one of the people that inhabit the planet. Therefore, it is essential to design and have the means to guarantee its safeguard, although, unfortunately, none is effective in itself. The article argues that, in the case of children, the problem is even more serious, because, due to their condition as people in development, they are part of a vulnerable group that requires special attention from the State and regulatory regulations specifically designed for their protection, especially if we put them in the perspective of migrants and the risks that illegal migration of minors, alone or accompanied, entails, such as human trafficking.
