The Journal Quaestio Iuris, indexed in the Web of Science, quarterly, in this volume 12, number 04, 2019, is pleased to inform all its readers that the Journal Quaestio Iuris has been classified by CARHUS Plus + as a Level A Journal in the area of Law. (http://agaur.gencat.cat/web/.content/Documents/CARHUS/CARHUS_2018/Carhus_to tal_cast2018.pdf).

CARHUS Plus + is a classification system for scientific journals in the areas of Social and Human Sciences that are published locally, nationally and internationally. This project is developed by AGAUR under the proposal of the General Research Directorate of the Generalitat de Catalunya, Spain.

CARHUS Plus + characterizes scientific journals at four levels, according to their quality: A, B, C and D. To belong to group A, journals must appear on the Web of Science or Scopus and must be within 35% of the journals best classified by impact factor or, failing that, by the Secondary Diffusion Compound Index (ICDS).

The journal is also pleased to publish the article "Cultural indicators of personal development and wellbeing in Mexico, Spain and Germany: a proposal for construction through feedback networks", by Jerjes Aguirre Ochoa, PhD in Management of Organizations. Senior Professor at the Michoacana University of San Nicolás de Hidalgo, Mexico; and Jaime Bravo Déctor, PhD student in Public Policy at the Institute for Economic and Business Research at the Michoacana University of San Nicolás de Hidalgo, Hidalgo, Mexico.

The article "Cultural indicators of personal development and wellbeing in Mexico, Spain and Germany: a proposal for construction through feedback networks" discusses the main proposals for the construction of cultural indicators in Mexico, Spain and Germany and compares them to the indicators used for the collection of cultural statistics. It is made clear by the research that individual indicators of development and well-being

have not been developed, or at least not at a plausible level for their application, although two decades have passed since Pattanaik proposed them for the area of culture. The article offers a distinct development proposal to address this problem, more viable for the entities responsible for culture in their territories, with the capacity to measure the impact of cultural actions implemented by individuals and with a greater probability of obtaining results that allow the analysis and evaluation of such actions.

In our Essays Section, we published 04 (four) essays, of which 02 (three) essays on public policies: "The extension of the Brazilian continental shelf beyond 200 nautical miles: opportunities and challenges" and "Hermeneutical possibilities for the judicial appreciation of administrative unconstitutional omissions : the control of unconstitutionality omissions in contemporary constitutionalism."

In this issue of the journal, we maintained our body of our referees / evaluators, from countless states in the country and foreign professors, in a total of more than 650 (six hundred and fifty) evaluating reviewers. We also publish, for immediate consultation of readers, the links to the various national and international indexes of journals and periodicals where our Journal Quaestio Iuris is indexed. We thank, as always, all readers, authors, reviewers and collaborators for their collaboration and trust and for the always excellent work done.
