The journal is also pleased to publish the article "Gender discrimination in brazilian labor market and the role of the private sector", by Irene Pietropaoli, Research Fellow in Business and Human Rights for the British Institute of International and Comparative Law - United Kingdom and Narciso Leandro Xavier Baez, Academic coordinator at the University of the West of Santa Catarina - UNOESC.

The article "Gender discrimination in brazilian labor market and the role of the private sector" seeks to discuss gender discrimination in the labor market in Brazil and to understand the role that the private sector plays in sustaining and combating gender inequality and disparity wage. This is done through the analysis of the main problems and challenges for achieving full gender equality. It is a study in the field of law, economics and social sciences. The article first reviews the history of gender equality in Brazil, highlighting current problems and advances, particularly in the area of legal protection for women workers. Then, it discusses the current issues of gender inequality and wage disparities at work in Brazil and analyzes the reasons for the persistence of such inequality. Finally, the article discusses the role of the private sector both in supporting gender discrimination and in promoting gender equality. This article recognizes the advances in gender equality achieved in Brazil in the past two decades, but considers that discrimination is the key persistent issue that needs to be addressed to completely eradicate this problem. In particular, special attention must be paid to the role of the private sector - something that has been overlooked in Brazil so far.

We also published in our Monographs Section a study called "Conventionality control and its applicability to Brazilian Criminal Law", by Gabriel Benedito Isaac Chalita, professor at Universidade Presbiteriana Mackenzie, professor at Pontifical Catholic University of São Paulo and Silmar Fernandes, Judge at TJSP and TRESP. Professor of Criminal Law at the Faculty of Law of Mackenzie Presbiterian University and in the Graduate Courses at School of Magistracy of São Paulo.

The monograph discusses the control of conventionality and its applicability to Brazilian Criminal Law, from an analysis of what is effectively understood by control of conventionality, that is, of its concept, legitimacy and mode of implementation or realization. The objective is, therefore, to verify the conditions of its effectiveness, in the light of the legislation, specialized doctrine and jurisprudence. The adopted methodology is the bibliographic and documentary research, of qualitative character. As a result, the article is expected to contribute to the advancement of Law Theory studies focusing specifically on the propaedeutic aspects of Criminal Law and Public International Law.

In our Essays Section we publish 04 (four) essays, 02 (three) essays on public policies: "Between transitional justice and torture: an analysis of authoritarian continuity in the current democratic state of law" and "Judicial activism and instrumentality of the procedure: a dialogue with Georges Abboud and Guilherme Lunelli based on the work of Cândido Rangelinamarco
