The article “The access to equitable work conditions in gender perspective: analysis of the legislative changes in the European Union” seeks to discuss gender equality in the labor market, which is enshrined in the International Covenant on Economic, Social and Cultural Rights, in its article 3, among others, together with international protection of second generation right reaffirmed in the Convention for the Elimination of All Forms of Discrimination against Women (article 11), and which, unfortunately, is still a delicate and time-consuming issue within the European Union. The article argues that, in 2012, there was a proposal for a directive on improving the balance between men and women in the position of non-executive director of companies listed on the stock exchange. However, analyzing the evolution of its legislative process, it appears that, since 2013, it has been in the first reading phase, with some amendments

being introduced by the European Parliament, and that it is still undergoing discussions in the Council, following the order of the ordinary legislative process of analysis in parallel. In this respect, the article analyzes the reinforcement of the entry of women in the labor market during the European economic development and the disparities in wages and representativeness in the most diverse high and medium positions that exist, and how this history affects Europe today, to conclude that, as far as possible, the European Union should be swift in terms of adopting a final directive to keep it up to date with the problem of gender equality.

We also published in our Monographs Section a study called “Human development in cyberculture: the importance of thinking about a resilient right”, by Luis Gustavo Gomes Flores,

Professor of postgraduate studies in the Master in Law at UNIJUÍ - Master in Human Rights, Rio Grande do Sul.

The monograph discusses the importance of the concept of resilience of law to think about Human development in face of the challenges brought by the set of trends called cyberculture by Pierre Levy . To this end, the monograph sought to answer the research problem that asks: what are the challenges of complex society and cyberculture for the improvement of the law and for human development? It is a reflective critical work that has as its general objective, to demonstrate the needs to think new possibilities of observation that takes into account the importance of innovation in law to face the social complexity, strongly marked by cyberculture. For that, the systemic constructivist method was used, which presupposes the use of assumptions and categories of the theory of autopoietic social systems and radical constructivism, as a way of observing and approaching the respective theme, as well as the use of bibliographic research. The conclusion resulting from the reading of the monograph is the possibility of observing new perspectives to be considered, from a potential not yet explored. Thus, considering the contributions of the resilience of the law, new possibilities are opened to think about human development from a systemic perspective.

In our Essays Section, we published 04 (four) essays, 02 (two) essays on different aspects of the dignity of the human person: “The (In)compatibility of the thesis established by the STJ in 692 about the repeatability of the social benefits received in good in faith in provisory care with the human dignity ”and “ Mothers in prison: wishes and wounded words”.

In this issue of the journal, we maintained our body of our referees / reviewers, from countless states in the country and foreign professors, in a total of more than 650 (six hundred and fifty) reviewers. We also publish, for the immediate consultation of readers, the links to the various national and international indexes of journals and periodicals where our Journal Quaestio Iuris is indexed.
