As with previous issues, in the current volume 17, issue 02, 2024, we publish 13 (thirteen) unpublished articles, including 07 (seven) foreign articles, as mentioned above. We also publish in our *Monographs Section* a study titled "*Religious Freedom and Inclusion: Secularism as the Ensuring Principle of Rights for the Lgbtqiapn+ Community*". The monograph analyzes the interaction between secularism and fundamental rights in the context of LGBTQIAPN+ rights. The evolution of secularism since the beginnings of colonization, influenced by the Catholic Church and its relationship with political power, established the need to separate religion and the State. The 1891 Constitution represents a milestone in this process, consolidating this separation and guaranteeing religious freedom and state neutrality. In the 21st century, the coexistence of religious diversity and secularism faces challenges. Religious and non-religious groups call for neutral secularism, which accommodates all beliefs and respects the absence of belief. Respect for secularism is fundamental for the rights of the LGBTQIAPN+ population. It protects equality, non-discrimination, dignity, and rights. Conflicts between religious beliefs and individual rights highlight the need for sensitive approaches in the search for solutions. In conclusion, this article reveals how secularism and fundamental rights are essential for an inclusive and just society. By addressing history, constitutional evolution, contemporary challenges, and the protection of specific rights, secularism emerges as a cornerstone of Brazil's cultural, religious, and social diversity.
