The Journal of Law city, journal ranked by MEC / CAPES as Qualis A1, Law, in this volume 07, number 03, the third 2015 year number, has the great pleasure to inform all readers and friends that, next year, 2016, we are becoming quarterly, with numbers in February, May, August and November.

In this volume 07, number 03 we are pleased to publish the article It is time to Marta give birth again: Villa San Luis, the decline of a dream of equality, by Teachers Marcos Pereira Diligenti and Mary Alice Medeiros Dias, respectively Professor and Adjunct Professor at Faculty of Architecture and Urbanism at the Catholic University of Rio Grande do Sul (PUC-RS). This article tells the story of Villa San Luis, located in the municipality of Las Condes, Santiago, Chile, a unique pioneer and revolutionary experience of public housing sponsored by the government of the Popular Unity of Salvador Allende. Salvador Allende, by proposing, in conjunction with the architect Miguel Lawner, the inclusion of economically poor in a zone with significant potential for economic recovery, broke with the logic of social apartheid in urban terms and signaled in an effective and representative way, in the case the Villa San Luis, one of the most important proposals offering worthy urban-spatial conditions for all city dwellers. In another perspective, there is the affirmation of the importance of permanence of people in the places where they built social ties and working relationships, as opposed to break these bonds commonly imposed on these populations by Latin American housing policies. These views were to the encounter of the achievement of a set of goals established since the presidential campaign of Allende. The article proposes as well to consider this history of Villa San Luis, later called Villa Carlos Cortés, in order to rescue to the current debate on social housing field its flagship potential and its unique singularity in Latin America, in the aspects of analysis related to socio-spatial segregation, gentrification, social movements and political management of the city.

In the section Essays we published 05 (five) essays, 02 (two) of them written by foreign professors : Public Policies For The Protection Of Human Rights In Colombia (1998 -

2010). The Risk Of Permanent State Of Emergency, by Carolina Maria Horta Gaviria and Ana Carolina Arboleda Gallo, both researcher professors from Universidad de Medellin, Colombia and Strategies For Conservation And Sustainable Tourism In Yabotí Biosphere Reserve, Argentina, by Elijah Gomez and Brian Ferrero, both from Universidad National Misiones - UNAM and the National Scientific and Technical Research Council.

As in previous occasions, we expanded the number of our referees / assessors, with the inclusion of many professors from many states in the country as well as many foreign teachers.

We are also publishing for immediate consultation of readers, links to the various national and international databases magazines and periodicals where our Journal of Law City is indexed.
