The Journal of City Law, classified by MEC / CAPES as Qualis A1, Law and registered in the Web of Science, is pleased to inform all its readers that the Qualis Law Commission, in October 2016, confirmed the qualification of the Journal as Qualis A1, Law. This is excellent news, which comes to crown the work of all the organizers of the Journal, encouraging us, more and more, to produce a better and better journal.

It is also worth mentioning that one of the main indexes of internationalization and visibility of a scientific journal in different scientific databases of international scope is the one calculated by the Matrix of Information for the Analysis of Magazines - MIAR of the University of Barcelona, Spain, which calculates the ICDS (Composite index of secondary diffusion).

This composite index is calculated from 05 global citation bases, 08 global multidisciplinary data bases, 95 specialized databases, and 07 international journal evaluation databases.

About the ICDS index, it is an indicator that shows the visibility of a scientific journal in different international scientific databases. A high ICDS means that the Journal is present in different sources of information of international relevance around the world. The index has a maximum value of 11 (eleven) points, which means that the Journal is disseminated internationally.

Our Journal of City Law was classified by the system of the University of Barcelona, Spain, as a journal of international scope and disseminated in the information systems of world magazines, reaching the good mark of the ICDS index of 9,5 points.

This index of internationalization is one of the best indexes achieved by a Brazilian Legal Review and not far from the Brazilian scientific journals of other better placed areas (Data Magazine, etc.), to demonstrate the internationalization of our Journal.

We publish the article "The public policy of sports and recreation in the city of Medellín, Colombia: participation in the processes of management of the sports scenarios of INDER - the institute of sports and recreation of Medellín" of the Professor José Fernando Tabares Fernandez, Professor and Phd. of University Institute of Physical Education, of University of Antioquia, Colombia. This research was funded by the Institute of Sport and Recreation of Medellín INDER and the Institute of Physical Education of the University of Antioquia, Colombia. The investigation also counted on the participation of Alejandro Escobar Chavarriaga, Carlos Esneider Patiño Torres and Elkin de Jesús Vergara Marín, as co-investigators and supporters of the process.

In this paper "The public policy of sports and recreation in the city of Medellín, Colombia: participation in the processes of management of the sports scenarios of INDER - the institute of sports and recreation of Medellín" the final results of the research are: the sports scenarios and the UVA in the active dynamics of the city, whose objective was to establish their relationship with social purposes. The research was based on a multi-method approach, with conversations, works, formats and socializations with managers of sports scenarios, users, COCIDES and INDER employees.
