The article "Crisis management and public policies. The trend toward regulatory practices in some countries" aims to investigate whether governments tend to implement regulatory policies in response to the Covid-19 pandemic and to examine the type of citizen response to different types of policies. Given that active and collaborative citizen participation is an essential element for proper crisis management, citizen resistance, active opposition and demonstrations in public spaces are detrimental to the success of government policies in the face of a crisis. Theoretical perspectives of crisis management and institutional analysis were employed, as well as qualitative case study methods and comparative studies. Different types of policies implemented in different countries were analyzed. The analysis shows that there is indeed a tendency to implement regulatory policies. It also identifies that where regulatory policies are created and implemented without taking into account contextual aspects, they usually catalyze citizen discomfort. Therefore, it is argued that the type of policy used is relevant in deciding what the responses of governments should be and its effect on legitimacy during crises.
